PROCEDURE

1. In a clean beaker , weigh the ingredients A.1 to A.3 and mix them together under stirring.
2. Add little by little A.4 into batch under stirring until it is fully dispersed.
3. Add then Hydrafence™ and Lingostem™.
4. In parallel mix the ingredients of phase B together and add this mix to phase A under high stirring.
5. Then adjust the color and pH successively with C.1 and C.2.

Appearance: Light Blue Frosted Thick Gel.
pH: 5,5-6,0
Viscosity (20°C , 100 rpm, spindle 7): 6000-13000 mPa.s
Stability Test: 3 months at 50°C, 40°C and RT.
