PROCEDURE

1. In a clean beaker, weigh A.1 and under rotor stator add it premix of A.2. to A.4.
2. When homogeneous add ingredient B.1 to B.4 one by one waiting for homogeneity between each addition.
3. Add then B.5 under regular stirring (dispersing blade).
4. Then add premix of C.1 and C.2 to batch.
5. Finally add ingredients of phase D one by one under stirring.
