### PROCEDURE

- 1. In a clean beaker, weigh A.1 to 80°C.
- 2. Then add to batch premix of ingredients A.2 to A.4 and stir until uniform using a dispersing blade
- 3. Then add A.5 to batch
- 4. In another beaker , prepare phase B mixing and heating the ingredients up to  $80^{\circ}$ C
- 5. Add slowly with high speed stirring phase B into phase A
- 6. Cool down under stirring until 75°C for adding ingredients of phase C one by one.
- 7. Then fill the molds and leave them still until the product becomes solid.

pH (1% aq sol): 6,5-7,5
Stability Test: 3 months at 50°C, 40°C and RT
