1. Organizer

3. Intention

The SOFW eEVENTS serial are small, themed digital B2B events designed to connect the home and personal care industries. They are designed to match participants and companies and to achieve the best possible and highest quality output and contact between buyers and sellers.

4. Registration & ticket fees

Admission for visitors, speakers and exhibitor staff is free of charge and includes participation in lectures, exhibition, discussion rounds, meeting and contact opportunities.

However, separate registration is required to attend the events.

5. Exhibition: fees for companies

5.1. The package price of € 2,000 includes a digital exhibition stand with various display options and a 20-minute presentation (incl. 5 min. Q&As).

5.2. Individual ancillary costs for additional services shall be invoiced to the exhibitor separately.

5.3. All prices are net and quoted in EUR. VAT will be added where applicable. The relevant current price list applies.

6. Exhibition: payment conditions

6.1. Balance is due 100% within 14 days after receipt of the invoice and is to be paid without deductions.

6.2. The date of the event is the date of performance.

6.3. Objections to the invoice shall only be considered if they are submitted in written form within 14 days of the invoice issue date.

6.4. Please state the invoice number as the purpose of payment.

7. Exhibition: cancellation policy

Cancellation must be sent in writing to the organizer by e-mail.

After signing the contract	50% of the total amount is due
30 day prior to the appropriate event	100% of the total amount is due
no show	100% of the total amount is due

The change of the particular maturity date is based on 12:00 pm (noon) CET.

8. Exhibition: subletting

The exhibitor is not permitted to fully or partially sublet or otherwise offer the booth allocated to him to third parties, unless explicitly permitted by the event organizer upon request. Permission must be given in written form.

9. Exhibition: advertising, promotion & copyrights

9.1. The exhibitor may only use their booth for advertising purposes. Further display options may be available at additional costs. In the interest of maintaining orderly exhibition operations, the event organizer reserves the right to revoke.

9.2. Advertising material in breach of legal regulations, is of an offensive, ideological/religious or political nature, is not permitted. The event organizer shall determine whether advertising is permissible according to these terms.

10. Electronical data processing & protection

The exhibitor and each participant in the event expressly agrees that the organizer (Verlag für chemische Industrie H. Ziolkowsky GmbH and commissioned partners) may store and process the data necessary for its and process the data required for its own purposes.

11. Photographs, illustrations & films

11.1. The commercial photographing, drawing or filming of persons of persons and/or lectures within the event is only permitted to persons designated by the organizer.

11.2. The organizer is entitled to have photographs, illustrations and/or film recordings made of stands, lectures and discussion rounds and to use them for advertising or press publications or similar without the exhibitor/participant being able to object on any grounds. This also applies to recordings made by the press and/or television with the consent of the organizer.

11.3. The photos, illustrations, films and other documentation materials produced by the organizer may only be used by the exhibitors/participants with the organizer's consent.

12. Purpose of the event serial logo

The official event serial logo may be used by the exhibitor in announcements of its exhibition pro-

gramme and/or in notices intended to promote a visit to the company's own stand. Any other use of the logo without the written permission of the organizer is improper.

13. Amendments & verbal agreements

All agreements, individual approvals and special arrangements must be in writing. Verbal agreements are only valid until a written confirmation can be made.

14. Cancellation of the event

14.1. The organizer reserves the right to cancel/postpone the whole or parts of the event.

14.2. In the event of cancellation of the event, all fees already paid (stands, sponsorship opportunities, etc.) will be refunded to the customer at 100%. Further claims for refunds will not be accepted by the organizer.

15. Place of fulfilment & jurisdiction

The place of performance is Thannhausen and the exclusive place of jurisdiction for all mutual obligations is Memmingen. The law of the Federal Republic of Germany shall apply.

16. Force majeure

In the unfortunate event that the event must be cancelled by the organizer for reasons of force majeure, the organizer is not, or only to a limited extent, obliged to provide the service.

Force majeure shall also include internal, lawful strikes by the operator of the venue and/or contractually bound third parties, which are necessary for the fulfilment of the obligations arising from the contract with the organizer.

All booking fees already paid will be refunded in full. Further claims for refunds will not be will not be accepted by the organizer.

The organizer reserves the right to change the programme at any time without notice. programme at any time without notice.
