Procedure:

Weigh and mix Part A with normal helix stirring. Weigh and mix Part B. Add Part B to Part A with normal helix stirring and stir for one hour. Add Part C to Part A+B with normal helix stirring and stir well. Add Part D and stir well. Add Part E and stir well.
